ANNUAL GENERAL MEETING – 12th May 2022

Chairman's Report

The year ending February 2022 has been another strange year because of the Covid-19 pandemic and its consequent restrictions. Our routine work parties resumed when we were out of lockdown and willing volunteers have managed to maintain all the trees on the orchard and along Over Lane. My sincere thanks to them all. The apple crop was very disappointing due to a very late frost in May last year at exactly the wrong time but no trees were damaged or lost.

Anne Roper has announced her intention to leave Baslow and thereby to stand down from the orchard group committee. On behalf of us all, I would like to thank Anne for her help and support over the last 10 years. She has been a moderating influence when some of the wilder ideas were discussed and invaluable for her skills in advertising and promoting our activities. We wish her well for the future. May I encourage anyone with an interest in the orchard to consider helping in her place; we may well need two people.

We maintain a relatively strong financial position, as will be outlined in the Treasurer's report. Because of the lack of activities last year, the Board of Directors decided to suspend subscriptions for that year, but we intend to resume subscriptions at the previous rate for 2022/23.

Unfortunately, Apple Day was cancelled again in 2021, not because of Covid regulations, but because we felt a reluctance among many people to mix too freely at that time. In effect this was a fortuitous decision as the weather was very poor on what had been earmarked for the day. As compensation, we intend to make 2022 an Apple day to remember, not least because it will mark 10 years of the orchard.

On behalf of the committee, I would like to thank all our members, village organisations and other individuals who continue to support us.
